Board of Trustees

Dear Congregation,

The Congregational Meeting held Sunday, December 15, was momentous in that all who attended participated in two items of church business that helped to build on our solid foundation for now and into the future. Before moving on to the business of our meeting, a sincere and hearty thank you from all of the Trustees goes out to all who participated in the meeting by offering helping hands as well as questions, comments, and ideas.

The two items of business we addressed were (1) viewing the architect's design options for our entrance and basement and (2) voting on two policy documents, the Covenant of Right Relations and the Destructive Behavior Policy. (In the interest of transparency, most of this article was borrowed from Amy Parrish's draft of the meeting minutes. Thank you, Amy.) Each of these items of business, separately and together, signify a range of opportunities for connection and growth for our church. Opening our doors to more and different kinds of events and activities and opening ourselves to deeper conversations and listening with open hearts and minds can spark our community creativity, generate greater diversity of ideas and viewpoints, and change the way we interact with each other and the wider community so that we can build a better, stronger church and help build a better, stronger world.

New-Build Design

Peter Wathen-Dunn of the New-Build Team introduced Derek Norton, of the firm Ridder Norton Architects (RNA), who presented four design options based on feedback RNA received from this congregation during various listening sessions. They based their designs on what we said we love about our campus and want to keep, most specifically, the woodland setting, meandering entry path and deck, the warmth and character of our sanctuary space, and the unique character of the existing architecture. In addition, there was a long list of things we want to improve, including low-to-no-maintenance deck materials, a completely finished basement with an elevator connecting upper and lower levels, a new kitchen, and additional restroom facilities. RNA offered four options, each progressively more complex and costly. Mr. Norton first showed the floorplan and then realistic drawings for each option. (Please note that the following are general descriptions of the options. Also note that no changes are planned for the RE Building.)

Option A: This baseline plan would alter the path of the deck to create more open space and a path to an on-deck gathering spot; add storage under the current deck outside the RE Building; rebuild the stairs to the lower level, with a stair along the curved wall; add an elevator; and replace the kitchen on the main floor with a smaller panty kitchen for making coffee and heating food for small events. Another addition would be a "green room" (changing / staging area) past the existing. The basement would be finished into a fellowship hall, either as one large or two smaller areas, with a kitchen and bathrooms, including a handicap-accessible bathroom with a shower and laundry. There would also be a terrace space outside the fellowship hall where people could sit, perform, have service, etc.

Option B: This includes items in Option A and adds a vestibule at the main entrance that would allow for a larger foyer space and more storage. There would also be a glass enclosure around the elevator with stairs leading down to the basement.

<u>Option C</u>: This includes items in Option B and covers the deck between the Meeting House and the RE Building. The cover would include a series of skylights to allow more light.

<u>Option D</u>: This includes items in Option C, but the covered area between the buildings would be completely enclosed and temperature-controlled.

Following Mr. Norton's presentation, he took questions, comments, and suggestions from the congregation. (Congregation input will be detailed in the finalized meeting minutes in the next few weeks after Amy returns from visiting with family.) The next steps in the build project include choosing a contractor. While RNA creates the design, a contractor will develop the project plans, including costs for materials, labor, permits, etc. The announcement of the contractor chosen is expected in January. Once pricing is available, the congregation will vote on a design option.

This leads to the most important step in the build project—funding. Trustee Don Gerson will be developing a Capital Campaign to raise money for our new-build project. He will need many helping hands and willing hearts to do this work. (And thank you, Renée Katz, for being the first to volunteer!!)

Covenant of Right Relations and Destructive Behavior Policy

BOT Chair Janet Overton first reacquainted the congregation with the purposes of the two documents (1) to outline standards of respectful behavior toward one another and (2) steps we can take to restore right relations when we fall out of covenant. In the months prior to the vote, the Board solicited feedback through listening sessions and written comments. Trustee Melissa Graham identified patterns of concerns we received through the feedback and offered a summary of how those concerns are addressed in the documents, then read the finalized documents. A question and comment period was next. (Again, congregation input will be detailed in the finalized meeting minutes in the next few weeks.) The vote was then taken. For the Covenant of Right Relations, 73 ballots were cast: 69 in favor, 1 opposed, 3 abstentions. For the Destructive Behavior Policy, 72 ballots were cast (one ballot had no response): 66 in favor, 2 opposed, 4 abstention.

The next steps are to find people to help us learn to have and work through difficult conversations if/when we fall out of covenant. The Covenant of Right relations notes that congregants can contact the Minister or a Board appointee to facilitate. We will be identifying facilitators from both outside the church and inside to allow choice when someone seeks help.

The Board will be communicating our progress as we work through this search, but please do not hesitate to contact the Minister or the Board if need be in the meantime. MULTIGENERATIONAL RELIGIOUS EXPLORATION

Yesterday afternoon, Paint Branch engaged in some difficult and important work. The Covenant of Right Relations and the Destructive Behavior Policy were both approved by the congregation. Hard questions were asked and answered and now it's time to move into the hard work of abiding by our agreements. I think of recent agreements I've been considering with and for myself. Agreements to move my body more, to keep my space (both at home and at work) more tidy and organized. Agreements about procrastination and how to avoid it. Agreements with myself and my family about being intentional with our time, our words, our presence. And it becomes evident that I need to sincerely practice who I'm going to be to abide with the agreements I've made with myself, my family and to you all at Paint Branch. As we consider who we need to be in order to live into the promises we've made, I will offer to you the practices I've agreed to: curiosity (a powerful antidote to anxiety), a willingness to be wrong, a willingness to reframe failure as an opportunity to learn and grow, patience, generosity, integrity, a willingness to listen especially when it's hard, a willingness to being flexible rather than rigid. My good people, the work is before us. Let us move into it with grace and fortitude and practice becoming the people who uphold their sacred agreements.

GA is the annual gathering of Unitarian Universalists for exploring the theological underpinnings of our faith via small and grand worship services, leaning fully into our mission and principles via hundreds of workshop options, and conducting the business of our denomination.

Consider attending the 2020 GA from Wednesday, June 24 through Sunday, June 28 in Providence, Rhode Island. Because Providence is relatively easy to get to (from this area, you can go by plane, train, or automobile) the planners anticipate that 4,500+ UUs will gather for this unforgettable experience.

Early bird Registration is now open at uua.org/ga/ Full-time registration is \$400 for adults, \$250 for high school youth and retired and candidate ministers, and \$150 for off-site registrants. Early bird registration closes on March 15 and fees go up. If you prefer smaller payments over a longer period, you can register, click "payment plan" and, for as little as \$50 down, you can spread out the balance of your registration between now and February 29.

The UUA is committed to the goal of making GA accessible to as many attendees as possible. Go to uua.org/ga/ to learn about scholarships to support participation – particularly of those from marginalized groups - and volunteer opportunities (work in exchange for registration). The UUA is committed to addressing the inclusion of all people, whatever their abilities might be, in all GA activities.

In addition to a variety of nearby hotels, attendees will also be able to book dormitory-style accommodations at two local universities. Also, UUs from local congregations will serve as host families for Home Hospitality. Make your hotel reservation beginning March 2 at 9 am Eastern.
